Build members' capacities through training, leadership opportunities, resource-sharing to strengthen human rights education and learning.











CRC: Principles and Features

Four Core Principles

- Non-discrimination
- Devotion to the best interests of the child
- The right to survival and development
- The views of the child



Notable Features

Children have a right to know their rights (Art. 42)

Children have a right to voice their opinions and be heard
(Art. 12/13)

Children have the right to health, water, food and education (Art. 24/28)

CRC: Key Dates

1946: UNICEF founded


1948: Universal Declaration of Human Rights (UDHR) passed by the UN

1959: UN adopts the *Declaration of the Rights of the Child*

1989: UN adopts the *Convention on the Rights of the Child* (*CRC*)

1995: U.S. becomes a signatory of the CRC

2003: U.S. ratified 2 of 3 Optional Protocols to CRC on children in armed conflict and the sale of children, child prostitution and child pornography.




Why hasn't the U.S. ratified the CRC?

196 nations have – US is the only UN nation that has not!

- Lack of education and awareness people don't know what it is or why it's important!
- Political infighting signed but not ratified or implemented
- Children seen as property or objects, not rights holders
- Challenged as "anti-family" but it's not!
- U.S. falling behind on many child wellbeing metrics
 - Children still sentenced to life without parole
 - o 20% of children live in poverty or are food insecure
 - Among highest morbidity & mortality rates of any developed nation
- U.S. perspective of being "better" than other nations
- U.S. political system
- Lack of investment in children and youth




